## 3. Approval of Minutes from June 22, 2002

Minutes were approved without amendment.

# 4. Report from Inspector Scrima

6/26/22 at Oakwood Rd. and Pulaski, graffiti, which included a swastika, was painted on a Lee Zeldin campaign sign. An arrest was made.

7/10/22 at Temple Chaverim, a letter was sent containing a racial element. There were no threats made, and no crime was committed.

7/20/22 threatening emails were sent to several local Jewish centers. It is being handled as a Harassment 2nd degree and Aggravated Harassment 2nd degree, and is being investigated by 2nd Precinct Crime Section.

8/2/22 at Sunshine Acres Park in Commack, a racial slur was carved into a children's slide. Hate Crimes is investigating.

8/16/22 at Family Service League in Huntington, a threat, including a racial slur, was made against a person. It is being handled as a Harassment 2nd degree and is being investigated by 2nd Precinct Crime Section.

To date, there have been 16 incidents in the county that included swastikas, 4 of which took place in the 2nd Precinct.

In 2021, there were a total of 34 incidents, 21 of which took place prior to 8/24/21.
